
### **REQUEST FOR QUOTATION**

The National Commission on Indigenous Peoples, Region 6 and 7, through its Supply Services, will undertake Negotiated Procurement by COMMUNITY PARTICIPATION for the Procurement and Delivery of Coffee Seedlings for the Indigenous Peoples beneficiaries of the Municipality of Laua-an, Province of Antique in accordance with Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 with **APPROVED BUDGET CONTRACT (ABC) of SEVEN HUNDRED EIGHTY-SEVEN THOUSAND PESOS (787,000.00 PhP)**

This Office invites interested bidders in this procurement and request that you quote your best offer for goods described in the bid form herein attached, subject to the following terms and conditions:

1. Bidders shall provide correct and accurate information required using this RFQ Form.
2. Must submit photocopy of valid Mayor's Permit, Income/Business Tax Return CY 2016, and Omnibus Sworn Statement upon submission of the duly accomplished Price Quotation.
3. Price Quotation **exceeding to the Approved Budget Contract (ABC)** shall be **automatically rejected**.
4. Award of contract shall be made to the lowest quotation which complies with the minimum technical specifications and other terms and conditions stated herein.
5. Price quotation, to be dominated in Philippine peso, shall include all taxes.
6. Payment to the supplier should be net of tax and shall enclose the BIR Form 2306 and 2307.
7. The lowest bidder shall be informed immediately, and may be asked to submit additional requirements after the opening of bids.
8. The NCIP reserves the right to reject any or all bid proposals, or declares the bidding failure and makes no assurance that procurement shall be entered into as a result of this invitation.
